Ki'l net estate nujo'tmn, ikana'ljiik, trustee kiswa liquidator kiswa heir ta'n na'tuan wejiej L'nuwey Residential school ta'n tujiw wejieajek na'kwek katu ketkunit aqq ta'n nepkaq ula tele'k kiswa kaqiaq sqoljuiku's 30, 2005?

Ta'n tujiw amuj, na ula wi'katikn wjit ki'l. Wejiaq klsuwaqn ula Federal Court. Ke tlwula'tike aq menaqaj kite'n mita ula kisi piluwa'tew ta'n teli asite'tasin fluwen klusuwaqn wejiaq.

KOQOWEY ULA WI'KATINU WJIT?

Etek ilsutasik certified class action teluwisik *ottfriedson v. Canada* (Federal Court File No. T-1542-12) wjit claim Na'kwek ikina'masultipni'k (wjit "ta'n wejita'jik" aqq wunijanuwa (wjit" Descendant class"). Na' kwekeweykina'matnook'kuo'm ta'n wejita'jik Iandian Residential School (IRS") pasik na'kwek aqq mu ketkunultikipni'k. Federal court sapa'toq kisi Ilsutasik Kisa'matultijik Wikewiku's 24th, 2021 aqq ta'n Kisa'matultijik Nike'mawa'latijik ta'n wejita'jik aqq Descendant class ta'n mu ejiklita'qipni'k.

Ilsutasik etek ta'n wejapesitew wen kitk ta'n wejiet aqq Descendant classes:

- **\$10,000 Na'kwek api kina'masit apankitijik:** Te's na'kwek apikina'masij wejiejek L'nuwey Residential Ekina'masultipni'k na'kwek pasik (katu mu ketqunultikipni'k) na kisi msintew \$10,000 wjit ta'n apankitujik. Ewikasik IRSs ta'n wekunk kiswa kisi skunsoq na'kwek Ekina'masultipni'k kisi we'jitasitew kaqtaqtesk wi'katikn, aqq online <http://www.justicefordayscholars.com/schools-lists/>. Ta'n tujiw case etek wen wejiet ta'n nepk kiswa kisinipik kaqiaq Sqoluiku's 30, 2005, ta'n nepkmaq scholar estates kiswa heirs jiptuk kisi suwa'tew na'kwek apikina'masij apankitut.
- **\$50 kji-pituimtlanaq etek suliewey wjit apoqnmnew apikina'mujik:** Kanat' apankitew \$50 kji pituimtlanaq wjit Na'kwekewey apikina'maultipni'k apaja'tasik suliewey wjit e'wasin apoqnasuti wlo'ti, kina'masuti, tli'suti, teli tlamsitasit, wetapeksit, aqq commemoration wjit wejiet aqq Descendant classes. Suliewey wjiatew ta'n mu nuta'nuk apankitmnew.

Ula kisi ilsutasik mu nuta'nuk wiaqten Band class. Mu koqowey etenuk wjit Ilsutasik ta'n Piluwa'te'n band class claim, ta'n siawa'sik trial.

Claim ta'n teli pijiaq \$10,000 Na'kwek ekina'masultipni'k apankitujuk panta'sitew Punamujuiku's 4, 2022. Kaqiaq ta'n tujiw kisi klutmn \$10,000 Na'kwek API kina'masultipni'k apankitujuk Wikewiku's 4, 2023.

Ula wi'katikn teluwek menaqaj ta'n sapa'sik Ilsutasik, claims pemiaq, ta'n nuta'q suwa'tn wejita'jik wjit suwa'tn suliewey Ilsutasik, aqq ta';n suwa'tn koqowey app teluwek me' keknuwa'tasik.

KAQI KNUWA'TIKEK WJIT NEKMOWEY

1. Koqowey net class action?

Class action na kutey lawsuit wjit pukwelkik majuinu'k ta'n newte' teltek claims. Ewnaqa te's newte' wen lukwatn tepkistek lawsuit, msit pasik ika'tuk lawsuit wjit msit wen. Ula teluisik "class" aqq ta'n wejita'jik teluisultijik "ta'n wejikina'masultijik".

Eykik ta'n wejita'jik na kaqi'sk pejita'jik ta'n tujiw class action tliaq aqq kelusit wjit msit wen. Ta'n wejita'jik aqq kisi tlipia'tijik e'wasikl wjit apoqnmuanew judge wjit nestmn ta'n kisi tlipiaq. Ula na teluwisijik ta'n ekina'mupni'k "representative plaintiffs".

2. Koqowey net ula call action wesku'tasik?

Ula class action teluisik *Gottfriedson v. Kanata aqq* Federal Court file ewikasikl mawkiljemkewe'l T-1542-12. Court "kisi kinu'tmut" ula class action Nipniku's 2015, teluwek ta'n nuta'q asite'tasin lawsuit wjit siawa'sin wjit class action.

Certification wjit class's action na siawa'sik ta'n asite'tk tela'sik ta'n siawa'tew wejiaq telukutijik plaintiffs wjit class wjit kaqama'sit wjit wen. Ta'n tujiw court ekina'muaj class action mu nuta'nuk l'te'n koqowey we'jitasik wjit teluwejik tla'sin wejiaq wen maliaptik plaintiffs teliaq na legally kiswa factually tepaqa'q.

Etekl classl ta'n ekinu'tmupni'k wejiaq court ula class action.

- **Ta'n wejita'jik** - msit L'nu'k ta'n wejita'jik IRS ta'n API kina'mujik na'kwek katu nu API tuknultikipni'k wela'sik, na'tami tele'kek 1920 aqq 1997. Ta'n elukwatmi'tij plaintiffs wjit ta'n mimajultijik wejita'pni'k class na Charlotte Gilbert, Diena Jules, Darlene Bulpit aqq Daphne Paul.
- **Wikmawa** - nekmuk, ta'n amko'tasultijik kiswa amkweywa'tipni'k ta'n wejita'jik. Ta'n maliaptik plaintiff wjit wikmawa na Amanda Big Sorrel Horse aqq Rita Poulsen.
- **Wutan** - Me' atelk wutan ta'n weskunm IRS wjit maqamikow kiswa ta'n weskunk/wekunajik wejita'pni'k mimajultijik, aqq ta'n ajite'tmi'tij wiaqpit class action. Ta'n ikana'lajik plaintiffs wjit wutan na Te'emlu'ps te secwepemc L'nuwey wutan aqq Sechelt L'nuwey wutann (shishalh Wutan).

Eykik mijuwa'jij'k IRSs na "wikultipni'k", teluwek eykik IRS wela'sik. Ula apikina'masultijik IRS mijuwa'jij'k na'kwek pasik katu mu ketkunultikipni'k na teluwisultijik "Na'kwek ekina'masultite'w". Na'kwek ekina'masultipni'k na wejita'pni'k ula class action.

Ta'n meawi matnmi'tij ikana'sik wejiaq ta'n ikana'tu'tij plaintiffs ta'n teluwek tela'tikek, pemiaq, aqq pema'toq IRS, wejiaq Kanata kiswa ta'n Kanata teluwet, sewiska'to'q ta'n wejita'jik

tli'suti'muwow aqq ta'n teli tlamsitasultijik, aqqo'pla'tu'tij ta'n teli nenmi'tij ta'n weta'qne'wasij aqq tli'suti, aqq kisa'toq o'pla'sik koqowey.

Class action menuwekej apankitunew ta'n wejita'jik ta'n teluwejik ewlo'tasultisni'k ta'n tujiw eymu'tijik IRS wjit na'kwek ekina'mupni'k. Class Action nuta'q apankitusin ta'n wejita'jik ta'n teluwejik o'pla'lujik ta'n wejita'jik IRSs wjit na'kwek ekina'mupni'k.

3. Koqowey net class action teliaqsip?

Ta'n wikultijik L'nuwey Residential Kina'matno'kuo'ml

Class Action mu wjit majuinu'k ta'n epliwi e'mu'tipni'k IRS wjit ta'n wikultiptni'k. Ula ta'n claiml ki's kaqikisa'tasik wejiaq Indian Residential Kina'matno'kuo'ml kisi Ilsutasik ("IRSSA"), ta'n wiaqtetew nenasik wejita'jik apankitew ("CEP").

Ta'n o'pla'lujik jilo'tasij aqq Nukwana'lujik

Ula class action mu wjit wen kisi o'pla'lut nukwana'lut kisna eplowi kesito'tj ta'n telipiep ekina'mupni'k IRS. NA'kwek ta'n ekina'mupni'k kisi juwa'taq claim ta'n kisi ankaptasitew ("IAP") wjit IRSSA wjit nukwaqna'luj kisna o'-Lowie kesito'tj wejiejek IRS NA'kwek ekina'mujek.

Federal L'nu'k Na'kwek Ekina'mupni'k

Ula class action mu weku'tmuk Federal Indian Na'kwek kina'matno'kuo'ml. Claim elt kutey o'pla'sik wjiaq Federal Indian Na'kwekey Kina'matno'kuo'm wiaqtekl McLean Federal Indian Na'kwek Kina'matno'kuo'ml kisi ilsutasik. Na'kwek ekina'mupni'k ta'n wikultijik IRS aqq ta'n elt eykisni'k Federal L'nuwey Na'kwek Kina'matno'kuo'm nike' elt kisi suwa'tew
