Ke tlwula'tike aq menaqaj kite'n mita ula kisi piluwa'tew ta'n teli asite'tasin
tluwen klusuwaqn wejiaq.**

• Koqowey teliaq:

- Class action lawsuit teluisik *Gottfriedson v. Kanata* nika' etliaq.
- Ula class action lawsuit wejiaq Na'kwek kisikina'masit ta'n wejiep ula Indian Residential Kina'matno'kuo'm ta'n tujiw ekina'mujuk na'kwek pasik (i.e., mu ketkunultikipni'k), ta'n wejita'jik winijanuwa (wikma), aqq ma'wt ta'n wetapeksij. Tela'sik mita ta'n teli tlamsitasik, tli'suti aqq ta'n kisi ewlo'tasultijik ta'n wejita'jik ta'n tujiw eyu'ti'tijek Indian Residential Kina'matno'kuo'm na'kwek.
- **Nika' etek kisa'tasik kisi ilsutasik wjit class action ta'n wejita'jik aqq ma'wt wikmawa claims.** Ula na teluwek Kaplno'l Kanata teluwet asite'tk ika'tasin aqq apankitnew ta'n wejita'jik aqq ika'tn suliewey wjit apoqnmuan ta'n wejita'jik aqq wikmawa, kulaman wjit ta'n wejita'jik aqq wikmawa kisa apoqnmuten.

Ke mnwi'kitis:

- Ta'n kiste'tasik ilsutasik mu wiaqtenuk ta'n Bandl kiska'toql, na siawa'sitew ta'n tujiw kaqiaq.
- Class action lawsuit aqq ma'wt ta'n kisi ilsutasik mu wesu'tasinuk ta'n kisi nukwaqna'lut. kisa wen kisi ewlo'tasij indian Residential Kina'matno'kuo'm Ula claim wejiaq Indian Residential Kina'matno'kuo'm wjit kisi ilsutasik kisa'matultijik.

- Class action lawsuit aqq ta'n kisi ilsutasik mu wekunmuk lukwatn wejiaq claim wjit ta'n wejita'pni'k Indian Na'kwek Kina'matno'kuo'm. Ula claim na kaqi wikasik wejiaq *McLean* Federal Indian Na'kwek Kina'matno'kuo'm kisi ilsutasik kisa'matultijik.
- Ewikasikl nikel ta'n Indian Residential Kina'matno'kuo'ml wejiaq ta'n ilsutasik kisi we'jitis ula ta'n wi'katikn kaqiwikasik.
- **Koqowey Nike' ap tela'sitew:**
 - Federal Court judge na kisite'tew wjit asite'tmn ta'n kisi ilsutasik. Judge na tlukwaqn wjit tlte'tmn ta'n kisi ilsutasik tepaqtekn, welte'tmn, aqq wjit wla'sin ta'n wjit wejita'pni'k aqq ma'wt wikmawa, ta'n ki's wejita'pni'k. Judge kisita'sitew wjit court teliaq ta'n poqjiaq Wikumkewiku's 7, 2021.
 - Jiptuk wen kisi ika'tew ta'n tel'te'tk ilsutasik ke'skmna'q kiswa ta'n tujiw tliaq court tliaq. Jiptuk je wen kisi ankaptitew wikuwaq online.
 - Ta'n tujiw judge sapa'toq ula ilsutasik, na msintew msit ta'n wen wejiep aqq ma'wt wikmawa. Ta'n tujiw judge mu asite'tmuk ilsutasik, na ma tla'sinuk aqq class action lawsuit siawa'sitew trial.
 - Ta'n tujiw wesku'tasik, lawyeraq wjit ta'n wejita'pni'k pipanima'tital judgel wjit asite'tmn ta'n telaptik aqq ta'n tli sika'tatew wen (telawtik).
- **Koqowey ki'l kisi tlukwetn:**
 - Mu nuta'nuk koqowey nikel tlukwen.
 - Ki'l kisite'tiak Imiaq ki'l ketu' lien ta'n tujiw sapa'sik ilsutasik tliaqal. Ula teluwek ki'l ika'tu'n ta'n tlte'tmn tlia teluwek tepaqtek, welte'tmn, aqq wjit wla'sin ta'n wjit wejita'pni'k aqq ma'wt wikmawa, ta'n ki's kiswa ta'n tujiw tliaq court jiksitasik.

TA'N KOQOWEY KEJITASIK

1. Koqowey net class action?

Class Action na lawsuit ta'n weaqtek wjit wen majuinu ta'n msit weskunk newte' legal claim. Ewnaqa te's newte' wen lukwatn tepkistek lawsuit, msit pasik ika'tuk lawsuit wjit msit wen. Ula teluisik "class" aqq ta'n wejita'jik teluisultijik "ta'n wejikina'masultijik".

Eyik ta'n wejita'jik na kaqi'sk pejita'jik ta'n tujiw class action tliaq aqq kelusit wjit msit wen. Ta'n wejita'jik aqq kisi tlipia'tijik e'wasikl wjit apoqnmuanew judge wjit nestmn ta'n kisi tlipiaq. Ula na teluwisijik ta'n ekina'mupni'k "representative plaintiffs".

2. Koqowey net ula ewikasik?

Etekl ta'n Tplutaqn e' wasikl jijuaqa court wjit ula class actions. Newte' ula Tplutaq na judge nuta'q sapa'tn ta'n kisi ilsutasik ta'n class action tepaqa'sik, welte'tasik, aqq ta'n kisa'toq wela'sik wjit msit wen ta'n wejiet. Kisi kitis me' koqowey ewikasik ula "Koqowey net teluwek ula ta'n kisi ilsutasik?" ula kewe'k ewikasik.

Piluwey Tplutaqn na, ke'skmna'q mu kisita'sik judge wjit sapa'tn ta'n kisi ilsutasik, wi'katikn tu'watew ta'n wejita'pni'k ula knuwa'tiken wjit: a) ta'n kisi ilsutasik aqq ta'n teluwek wjit nekmuk; aqq b) ta'n wejita'jik kisi wiaqa'lutaq ta'n tujiw sapa'sik, kulaman kisi wiaqa'taq ta'n nekmuk telte'tmi'tij tujiw tlimanew judgeal. Ula na ewikasik.

3. Koqowey net ula call action wesku'tasik?

Ula class action teluisik *Gottfriedson v. Kanata aqq* Federal Court file ewikasikl mawkiljemkewe'l T-1542-12. Court asite'tk wjit lawsuit siawa'sin wjit class action Nipniku's 2015.

Etekl Ne'sikl classel wjit ula class action:

- **Ta'n mimajultijik wejita'jik** - Msit L'nu'k ta'n wejita'jik Indian Residential Kina'matno'kuo'm ta'n kekina'masulti'pni'k katu mu ketkunultikipni'k, ula tele'kek 1920 kiswa 1997. Ta'n elukwatmi'tij plaintiffs wjit ta'n mimajultijik wejita'pni'k class na Charlotte Gilbert, Diena Jules, Darlene Bulpit aqq Daphne Paul.
- **Wikmawa** - nekmuk, ta'n amko'tasultijik kiswa amkweywa'tipni'k ta'n wejita'jik. Ta'n maliaptik plaintiff wjit wikmawa na Amanda Big Sorrel Horse aqq Rita Poulsen.
- **L'nuwe'kati** - 101 l'nuwe'kati'l ta'n wekunkis Indian Residential Kina'matno'kuo'm na'te'l kiswa kikjuk ta'n weskweywa'tipni'k ta'n nika'/sa'q wejita'pni'k, aqq ta'n kisite'tmi'tij ika'lsin ula class action. Ta'n eluwatmi'tij plaintiffs wjit Band class na Tk'emlúps te Secwépemc L'nuwe'kati aqq Shishalh L'nuwe'kati.

Eykik ta'n wejita'pni'k Indian Residential Kina'matno'kuo'm na "wesowita'pni'k", ta'n ketkunultipni'k Indian Residential Kina'matno'kuo'm wela'kw. Ta'n wejita'jik Indian Residentail Kina'matno'kuo'm ta'n tujie ekina'masulti'tijek na'kwek katu mu ketkunultikipni'k na teluisultijik "Na'kwekey kina'masultite'wk", aqq nekmuk na wejimimajultijik ta'n wejita'jik ula wjit class action.

Ta'n mekweye'k wije'tikl kisa'matultijik class action na tela'sik, ta'n tela'sik aqq ta'n ikana'toq indian residential Kina'matno'kuo'm sewiska'latki'k ta'n wejita'pni'k ta'n tli tlamistmi'tijek aqq tli'sutio'muwek, siwiska'tu'tijiek ta'n koqowey kejitu'tijnek ta'n wetapeksit aqq ta'n teli'sipnaq, aqq kisa'toq mu newte' tlein. Class action ankaptik kisi apankitunew ta'n wejita'jik ta'n kisi jilayujik ta'n tujiw eymi'tijek Indian Residential Kina'matno'kuo'm pasik na'kwek. Class action elt ankaptik kisi apnakituan wikmawa ta'n wejita'pni'k aqq ma'wt ta'n wetapeksit ta'n teluwet wejiet kisi ewlo'tasit ta'n wejita'sjik Na'kwek ekina'masulti'tijek ula Indian Residentail Kina'matno'kuo'ml.

Ula class action mu weku'tmuk Federal Indian Na'kwek kina'matno'kuo'ml. Claim elt kutey o'pla'sik wjiaq Federal Indian Na'kwekey Kina'matno'kuo'm wiaqtekl McLean Federal Indian Na'kwek Kina'matno'kuo'ml kisi ilsutasik. Wjit me' ketu' jijitu'n McLean Federal Indian Na'kwek

Kina'matno'kuo'm ilsutasik, aqq ma'wt ta'n ewikasikl kina'matno'kuo'ml, lietis :

Ula class action mu wjit wen nukwaqna'lup kiswa me'ki o'pla'lup kutwey jileyut ta'n tujiw eykek Indian Residential Kina'matno'kuo'm. Ula claim wiaqtekip Indian Residential Kina'matno'kuo'm Ilsutasik Kisa'matultijik.

Ula class action mu wiaqtenuk wjit pasik wen wejiep Federal Indian Na'kwek Kina'matno'kuo'm kiswa pasik wejiep Inidan Residential Kina'matno'kuo'm ta'n weskowa'sip. **Katu, wiaqtek ta'n wen:**

- a) **Etekl** na'kwekl newtipukqekl ekina'masimk, wejita'jik Federal Indian Na'kwek kina'matno'kuo'm aqq/ kiswa Indian Residentail Kina'matno'kuo'm ta'n pasik wjit wejita'jik; **katu**
- b) wjit newte' kiswa me **pilewe'l** kina'matno'kuo'ml newtipunqekl, elt wejita'jik Indian Residentail kina'matno'kuo'm wjit pasik **Na'kwek ekina'masip**.

Ta'n wejita'jik kiswa wikmawa ta'n menuweket mna'sin (mu wiaqpin) ula class action ke'skmn'q kaqianuk Keptekewiku's 30, 2015, mu wiaqpulti'k class action aqq ma tala'sinuk ta'n ki's kisi ilsutasikip. Mista kaqia'q ta'n teli asite'tasik piskwa'tasin, mu nike' asite'tasinuk mna'sin/jikla'sin ula class action.

TA'N KISI ILSUTASIK

4. Talte'tmn ki'l ula ta'n teluwek kisi ilsutasik?

Kanata aqq ta'n maliaptmi'tij plaintiffs kisi wi'kik wisun wjit ilsutk wjit ila'tn ta'n wejita'jik aqq wikmawa ula class claims. Jiptuk aqq misoqo Federal Court sapa'toq ta'n ilsutasik kis'matultijik, katu pasik nike' pasik ta'n kisi ilsutmi'ti. Ta'n wejita'jik ma kisi pikwa't't laq ma kisimsinmi'tik apankitnew misoqo kisi ilsutasik sapa'sik wejiaq Federal Court.

5. Wen wiaqpit ula ta'n kisi ilsutasik?

Msit ta'n wejita'jik ta'n ewikasik Indian REsidential Kina'matno'kuo'm na'kwek pasik, pasik kaskwi kiswa msit na'kwek eyk newtipunkek, ma'wt wiaqpultijik ula ta'n kisi ilsutasik. Ta'n ewikasik Indian Residential Kina'matno'kuo'm na Indian Residential Kina'matno'kuo'm ta'n etekip, kiswa ta'n l'tekip, na'kwek ekina'masultipni'k.

Ki'l nmitis msit ewikasik Indian Residential day Kina'matno'kuo'm ta'n wiaqtekl ula class action ta'n kaqiaq ula wi'katikn aqq ta'n ewikasil Schedule E wjit ta'n kisa'matultijik ilsutasik. Ta'n ewikasik msit naskwa'tasik ta'pu:

- Ewikasikl 1, wiaqtek Indian Residentail Kina'matno'kuo'ml ankaptmi'tij ukjen wen tele'kek; aqq
- Ewikasik 2, ta'n wiaqtekl Indian Residential Kina'matno'kuo'ml ta'n eymu'tipni'k na'kwek wejita'jik ekina'masultipni'k.

Kitk ewikasikl 1 aqq 2 Kina'matno'kuo'ml wiaqtekl ilsutasik.

Ta'n pasik wen api kina'masit ta'n mimajit me' Squljewiku's 30, 2005, katu nepkip weja'tikempk, weiaqtek ta'n kisi ilsutasik. Heirs ta'n nepu'tipni'k ta'n wejita'pni'k jiptuk msintaq wjit piskwa'tn claim. Me' ap ta'n keknuwa'tikek wjit estate clam kisitasitew etekl "Taliksi msintew wen wejiet ta'n teluwejik wejiaq ula kisi ilsutasik?" ula ewikasik kewe'k.

Mist wikmawa ta'n wejita'jik wiaqpultijik ula ta'n kisi ilsutasik.

Ula kisi ilsutasik mu nuta'nuk wiaqten Band class. Mu koqowey eyknuk ula ta'n ilsutasik ta'n piluwa'tew Band class claim, wjit siawa'sin ta'n ketu' tliaq ta'n kisi ilsutasik.

6. Koqowey wen wejeket ula ta'n kisi ilsutasik?

Kanata kisa'matultijik:

- Ta'n apankitujik wejita'ipni'k iknmujik \$10,000 Na'kwekek eymu'tipni'k apankitunew suliewey. Ta'n te'sit wen wejiet api kina'masit na'kwek suliewey apankututen. Msit ta'n sapa'tasik na ukjiatew Kanata.
- Kanata elt apankitew \$50 million wjit na'kwek ekina'masultipni'k wjit apaja'tnew wjit e'wasin apoqnmen ta'n wejita'jik aq ma'wt wikmawa, ta'n ewi'tasik ula kowe'k.

Wjit kitk ta'n mimajultijik wejita'jik aq ma'wt wikmawa, ilsutasik teluwek ta'n telawtik aq q keskmteskmn trial, aq naqateskmn ta'n tujiw kisita'sultinew, na'tami newtipukekl me' el'miaql wejkupaqtekl tla'sin.

Na'kwek Ekina'masultipni'k ta'n Apankitutaq

Newte' na'kwek ta'n apankitut \$10,000 eknmuten wen wejiet ta'n tujiw piskwa'toq claim aq sapa'sik. Claim sapa'sitew ta'n tujiw:

- L'tasik ke'skmna'q kaqianuk, na na'tami 21 Tepknusutuwe'l ta'n tujiw kaqi suwa'tasik;
- Ta'n wejita'jik mimajultinew Skuljuiku's 30, 2005; aq
- Ta'n wejita'jik Na'kwek na'tami newte' kiswa me' Newtipukekl ta'n mena'q mesnmuk: (i) Teltek kutey ki's iknuksinek Indian Residential kisi ilsutasikek, (ii) ta'n pasik tekn wejiaq *McLean* Federal L'nuey Na'kwek Kina'matno'kuo'm, kiswa (iii) ta'n pasik tekn apankituksinek piluwey kina'matno'kuo'm ta'n etek *McLean* kisi ilsutasik ewikasik.

Ma mna'tasiknuk Na'kwek Ekina'masultipni'k teli Apankitujik. Msit ta'n sapa'sik mesntaq newte' teli apankitujik \$10,000, tliaq ta'n te'sik na'kwekl wejiep ta'n tujiw ekina'mujek.

Na'wek Ekina'masijek Apaja'tmk teli Apankitujik.

Na'kwek ta'n Ekina'masultipni'k Apaja'tnew Suliewey telawtik \$50 million wjit ika'tn aq japesin ta'n wejita'pni'k aq ma'wt wikmawa. Suliewey e'wasitew wjit apoqnmuwan wen ila'sin, wlayasin, Telikina'masin, Tli'suti, Teli tlamsitasin aq commemoration, aq ikana'tew ta'n mu awtukwek wejiaq Kanata.

7. Koqowey ta'n wejita'jik aq wikmawa puna'tu'tij ta'n tujiw kisi ilsutasik.

Ta'n tujiw sa'siewij kowoey ula teluwek, ta'n wejiet aq wikmawa class claim na wi'tasitew class action aq Kanata mesntew "tewa'tasik" wjit wen pema'toq ta'n msit eymu'tipni'k aq wikmawa. Ula teluwek Nekmowey:

- Mu eyknuk ta'n wejita'jik kisim smatal Kanata wjit ta'n telipia'tip ni'k kiswa ta'n teli jiloayujuk ula Na'kwekewey ekina'mujek Indian Residential Kina'matno'kuo'ml.
- Elt wen wikmawa ta'n wejita'pni'k ma kisi teluwek Kanata tla'taqn wjit jile'kip kiswa jileyup ta'n tujiw eykek Na'kwek Indian Residential Kina'matno'kuo'm.

Msit tewa'tasik klusuwaqn wejitasin section 42.01 aqq 43.01 wjit llsutasik kina'matultijik. Tlwula'tike aqq ukjikisapskn Class Counsel ta'n tujiw koqowey ketu' pipanikesin ula wjit koqowey tewiaq aqq pipanim koqowey wesku'tasik.

8. Talkis ta'n wejiet Class Member mesink koqowey wejiaq ta'n kisi llsutasik?

Wjit mesink wen Na'kwek eymu'tipni'k apankitnew, ta'n wejita'jik mesintaq ta'n piskwa'toq ta'n teluwek ula wi'katikn wjit claim ta'n ikana'toq. Wjit claim ta'n elakutk ta'n pasik teken Indian Residential Kina'matno'kuo'm ta'n Ewikasik 1, mu nuta'nuk koqowey piluway wi'katikn ika'tn. Wjit claim wejiaq ta'n pasik tekn Indian Residential Kina'matno'kuo'ml ta'n Ewikasikl 2, ta'n nasiwi'kusit nuta'tew ika'tn eluwi'tmasit aqq teluwek wejiep na'kwek pasik aqq ika'tis ta'n tett weskowa'si'tip ta'n tujiw elienek Indian Residential Kina'matno'kuo'm pasik Na'kwewey. Eykik ta'n apoqnmultaq ta'n tela'timk wjit elukwatimk wi'katikn sworn klusuwaqn.

Jiptuk ta'n wejita'pni'k ta'n nepu'tipni'k weja'tikemk Squljuiku's 30,2005, wikma'jl kisi piskwa'tew claim. Jiptuk ta'n tujiw estate weskweywj executor, ta'n nuji maliaptik, trustee kiswa liquidator (wejiaq ta'n teli ilsutkisnek ke'skmna'q nepmukek kiswa wejiaq court), na nekm majuinu mesintew wejiaq estate. Ta'n tujiw me eyruk estate ta'n nuji maliaptik, trustee kiswa liquidator, na na'tuan wikmawa mesintew ta'n wejiep msintew. Ta'n wen ika'toq nuta'q ika'tn koqowey teluwek ta'n telakumatl ta'n nepkipmaq. Ta'n tela'timk wjit l'ka'tn klusuwaqn wjit ta'n wejiep ta'n nepkipmaq ke'skmna'q Skuljewiku's 30, 2005, ewikasik Estate Claim ta'n teli pijiaq Schedule D ta'n kisi llsutasik.

Claimants ta'n claim anka'qtasik mita ta'n ikana'toq claim mu wlte'tmuk ta'n wejiet ekina'mup Na'kwek ta'n ewikasit Indian Residential Kina'matno'kuo'm kisi klutew iliankaptasin. Claimants mesueke'tij iliankaptasin kisi suwa'tew aqq knuwa'tuan lawyeraq wjit ta'n wejita'pni'k ta'n mu awtinuk, kiswa wjit tliman na'tuan lukwatn aqq anpankituan lawyer ta'n nekm tlialsutew.

Ula ta'n kaqkisa'tasik claim telipijiaq kisi we'jitasitew Schedule C wjit kisi llsutasik, aqq Estate claim ta'n telipijiaq wi'katikn kisi we'jitasitew ula Schedule D wjit ta'n llsutasik.

TA'N KISI ILSUTASIK SAPA'TASIK KLUSUWAQN

9. Koqowey net ta'n lksutasik sapa'tasik hearing?

Ta'n lksutasik sapa'sin hearing court ta'n judge ankaptitew sapa'tn llsutasik. Ta'n ankaptik judge ika'tew tliaq tepaqtek, welte'tasik, aqq wjit wla'sin wjit ta'n wejia'jik. Judge ankite'tew msit ta'n kisa'matultijik ta'n msit wiaqtetew. Ma judge kisimkn muk aqq kisi suwa'tuk kijka' ta'n llsutasik sapa'sik kiswa mu sapa'sinuk.

Ke'skmna'q mu ilsutasik sapa'sinuk, lawyeraq wi'kitaq koqowey e'tmatk wjit koqowey wjit judge nuta'q sapa'tn tan ilsutasik. Ta'n tujiw etliaq hearing, lawyer ika'tew ta'n telte'tk koqowey judge nuta'q sapa'tn ta'n kisi ilsutasik.
