**Ta'n tujiw amuj, na ula wi'katikn wjit ki'l. Wejiaq klsuwaqn ula Federal Court. Ke tlwula'tike aq menaqaj kite'n mita ula kisi piluwa'tew ta'n teli asite'tasin tluwen klusuwaqn wejiaq.**

### **Koqowey ula wi'katikn wjit?**

Ta'm Ilsutasik etek certified class action teluisik *Gottfriedson v. Kanata* ( *Federal Court File No. T-1542-12*) wjit claim Na'kwek kisi Kina'masultijik ( "*Ta'n wejiet Apikina'masit*") aqq winjanuwaq ( "*Descendant Class*"). Na'kwek Api Kina'masultijik na ta'n wejita'pni'k Residential Kina'matno'kuo'm ta'n tujiw Na'kwek pasik aqq mu ketkunultikipni'k wela'wk. Federal court sapa'toq kisi Ilsutasik Kisa'matultijik Wikewiku's 24th, 2021 aqq ta'n Kisa'matultijik Nike'mawa'latijik ta'n wejita'jik aqq Descendant class ta'n mu ejiklita'qipni'k.

### **Koqowey Ilsutasik Sapa'sikek?**

Ula Ilsutasik wiaqtek ta'n wejapesit wen wjit kitk Na'kwek Api kina'masit wejita'jik class aqq Descendants classl.

- **\$10,000 Na'kwek api kina'masit apankitijik:** Ta'n tujiw apikina'masijek Na'kwek eykek Indian Residential Kina'matno'kuo'm ( katu mu ketkunikip wela'wk) ta'n tujiw ula tele'kek 1920 aqq 1997 kisi mesintew wjit \$10,000 Na'kwek Ekina'masijek Apankitujik Telawtik. Ta'n ewikasik Indian Residential Kina'matno'kuo'm ki's ala'toqip kiswa kisi ala'soq Na'kwek ekina'masultijik kisi we'jitasitew ula kaqiaq ula wi'katikn aqq online <https://www.justicefordayscholars.com/schools-lists/>. Ta'n tujiw case etek wen wejiet ta'n nepk kiswa kispipik kaqiaq Sqoluiku's 30, 2005, ta'n nepkmaq scholar estates kiswa heirs jiptuk kisi suwa'tew na'kwek apikina'masij apankitut.
- **\$50 kji-pituimtlnaqn etek suliewey wjit apoqnmnew apikina'mujik:** Kanat' apankitew \$50 kji pituimtlnaqn wjit Na'kwekewey apikina'maultipni'k apaja'tasik suliewey wjit e'wasin apoqnasuti wlo'ti, kina'masuti, tli'suti, teli tlamsitasit, wetapeksit, aqq commemoration wjit wejiet aqq Descendant classes. Suliewey wjiatew ta'n mu nuta'nuk apankitmnew.

Ula Ilsutasi mu wiaqtenuk Band Class. Mu koqowey ula ilsutasik ma tala'tuk wutann class claim, ta'n siwawa'sik mu na'asineu ilsutasik.

### **Ta'lek class wejiet kisitew claim wjit wen \$10,000 Na'kwek apikina'masijek apankitusin suliewey?**

Claimants jiptuk poqji ika'taq claim ta'n tujiw claim etliaq panta'sik Puna'mujuiku's 4, 2022.

Kaqiaq wjit piskwa'tmk claim na Wikewiku's 4, 2023 11:59 p.m. Claimants nuta'q wiskow piskwa'tnew wjit ma meso'tmi'tik claim kaqiaq.

Ta'n tujiw ki's mesinmin kutey ta'n ula teltek suliewey wejiaq Residential Kina'matno'kuo'ml Ilsutasik Kisa'maimk (IRSSA), kisna ta'n tujiw ki'l kisi mesinmin wejiaq McLean Na'kwek Kina'matno'kuo'm Ilsutasik, ki'l jiptuk kisi suwa'tn me' wejiaq Na'kwek Kina'matno'kuo'm apankitujik Ilsutasik, ika'tu'n mena'q ankaptasinuk apankituksin wjit msit newte' newtipunkekl wejienl wjit Na'kwek ikna'musinek.

Ta'n tujiw Claim ikana'toq nemitoq claim wi'katikn mu kaqikisa'tasinuk kisna koqowey etek ika'tasik claim mu wiaqtenuk, Claim ta'n maliaptik ukji kisapknultew wjit pipanimulnin me' ap koqowey

Ta'n tujiw claim mu sapa'sinuk wejiaq claim maliaptmi'tij wjit na'tukoqowey nemitasik (koqowey piluwey wiaqtek kina'matno'kuo'm ta'n mu weskunukip Na'kwek kina'masuti kisna elt kutey na'kwek ekina'mupni'k nupu'tipni'k ke'skmna'q Squoljuku's 30, 2005), kisi pipanimatis wjit iliankaptasin. Ta'n tujiw tla'sik, ki'l kisi suwa'latis lawyer apoqnmulnin lass Counsel (ta'n ma awtinuk), ki'l kisi klusitis wjit ki'l, kisna kisi mkinatask ki'l lawyer (katu ki'l amuj pa apankitisk). Ta'n newtukwalukwet ankaptik kisite'tew ta'n pasik claim aqq ta'n newtukwilukwat ankaptik kisita'sitew kaqiaq aqq toqa'tasik.

### **Ta'nuk sntis ni'n ilsutasik apankituksi?**

Ta'n tepaqa'q claim wjit mimajit Na'kwek api kina'masij na wiska'qtasik aqq, nike' ta'n tujiw elkitmin mu pekije'nuk tepknusutewe'l ika'tew claim.

Ta'n tujiw ki'l eltu'n Estate Claim wjit heir ta'n nepkipmaq eina'masip ta'n mimajip me' Squljuiku's 30, 2005, ki'l claim ma ankaptasinuk misoqo kaqiaq claim wjit ankaptmin mu claim mu ki's eteknuk wejiaq estate executor, administrator, trustee kisna liquidor, kisna wjit heir newte' kisna aji espitek ikana'sik.
